**OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP
OF PORTAGE AUTHORIZING THE COLLECTION OF 511
TAXES AND DIRECTING OTHER NECESSARY AND
PROPER ACTION.**

BE IT RESOLVED, by the Board of Supervisors of the Township of Portage (the "Township"), as follows:

SECTION 1. PORTAGE TOWNSHIP, Cambria County, Pennsylvania, intends to collect, in the Year 2016, the following taxes that were imposed by Ordinance at an earlier date:

1. Wage/Earned Income Tax
2. Per Capita Tax
3. Real Estate Transfer Tax
4. Local Services Tax

and any other Act 511 Taxes, license fees or permits previously established or that may be established in the Year 2015, with the exception that the Per Capita Tax shall be increased from \$2.50 to \$3.25 per year.

SECTION 2. The President or Vice President and the Secretary or Assistant Secretary of this Township, as applicable, are authorized and directed to execute, to attest, to acknowledge and to deliver the documents, on behalf of this Township, in the form so approved.

SECTION 3. Proper officers of this Township are authorized and directed to execute all documents and to do all other acts that may be necessary and proper to carry out this Resolution and the undertakings of this Township.

SECTION 4. This Resolution shall become effective in accordance with law.

SECTION 5. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of this Township that such remainder of this Resolution shall be and shall remain in full force and effect.

SECTION 6. It is declared that the adoption of this Resolution and the execution, acknowledgment and delivery of the documents are necessary for the protection, benefit and preservation of the health, safety and welfare of inhabitants of the Municipality.

SECTION 7. All other resolutions or parts of resolutions inconsistent herewith expressly are repealed.

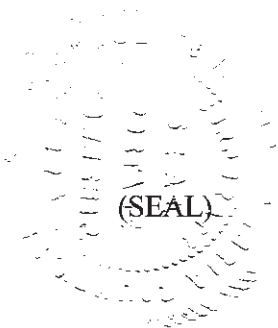
