***AMENDMENT TO  
PORTAGE TOWNSHIP JUNK YARD ORDINANCE NO. 1988-1***

WHEREAS, the purpose of this Ordinance is to amend the aforementioned Ordinance #1988-1, in part, by increasing the annual licensing fee from \$25.00 to \$125.00, and to authorize amendments to the fee structure by Resolution in the future.

BE IT ORDAINED AND ENACTED, BY THE TOWNSHIP OF PORTAGE, Cambria County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows::

**SECTION 1. TITLE**

This Ordinance shall be known as the "Portage Township Junk Yard Ordinance Amendment #2".

**SECTION 2. LICENSE**

Effective immediately, the annual licensing fee set forth in Section 3 of Ordinance 1988-1 is increased from \$25.00 to \$125.00.

**SECTION 3. FUTURE AMENDMENTS**

Any future amendments to the annual fee structure shall be authorized/approved by the adoption of a Resolution at a public meeting by a majority of the Board of Supervisors.

**SECTION 4. RENEWAL OF LICENSE**

Renewal of any junk yard license upon the expiration of same, or after revocation, shall require conformity with this ordinance and all other requirements of the original licensing.

**SECTION 5. SEVERABILITY**

It is the intent of the Municipality that the provisions of this Ordinance are severable and the invalidity of any Section, subsection, clause or provision of this Ordinance shall not affect or impair the validity of any other part of this Ordinance which can be given effect without the invalid part or parts. Prior Ordinance 1993 - [REDACTED] shall remain in full force and effect.

**SECTION 6. AUTHORIZATION OF OFFICERS**

The proper officers of the Municipality, as applicable, are authorized and directed to execute, to attest, to acknowledge and to deliver all documents, on behalf of this municipality, in the form so approved. Proper officers of this Municipality are authorized and directed to execute any and all documents and to do any and all other acts that may be necessary and proper to carry out this Ordinance and the undertakings of this municipality.

**SECTION 6. AUTHORIZATION OF OFFICERS**

The proper officers of the Municipality, as applicable, are authorized and directed to execute, to attest, to acknowledge and to deliver all documents, on behalf of this municipality, in the form so approved. Proper officers of this Municipality are authorized and directed to execute any and all documents and to do any and all other acts that may be necessary and proper to carry out this Ordinance and the undertakings of this municipality.

**SECTION 7. REPEALER**

All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance are hereby repealed insofar as same affects this Ordinance.

**SECTION 8. EFFECTIVE DATE**

This Ordinance shall become effective immediately, or as soon as legally permissible and shall remain in effect unless and until subsequently repealed, replaced, or amended.
